I **Jerald Sigman** AN OFFICER WITH THE CABOOL POLICE DEPARTMENT, UPON MY OATH AND UNDER PENALTIES OF PERJURY, BELIEVE THE FOLLOWING OFFENSES OCCURRED.

- 1 Murder 1<sup>st</sup> Degree Rsmo 565.020 1002101.0

I HAVE PROBABLE CAUSE TO BELIEVE THAT **Daniel W. Chapman 11-14-1956** [REDACTED] WHO RESIDES AT 12402 Valley View Rd. Mountain Grove, Mo. 65711 . COMMITTED ONE OR MORE CRIMINAL OFFENSES.

THE FACTS SUPPORTING THIS BELIEF ARE AS FOLLOWS:

At 2022 hrs. Officer Darter was dispatched to a reported shooting at Sinclair Gas Station located at 317 Ozark. Upon arrival Officer Darter found a female identified as Sandra M. Chapman 111055 on the floor inside of the Sinclair station deceased.

At approximately 2031 hrs. I arrived on scene and was advised by Officer Darter that [REDACTED] [REDACTED] witnessed the shooting. I talked to Darren and asked him to come to Cabool Police Dept to be interviewed.

At 2057 hrs. I interviewed [REDACTED] [REDACTED] stated he pulled in front of Sinclair and parked between the front door and the first gas pump. [REDACTED] stated he exited his pick up and took about two steps and witnessed two individuals he recognized as Dan and Sandy Chapman standing inside Sinclair in front of the soda cooler. [REDACTED] stated Dan Chapman motioned for him to leave by waiving his hand at him. [REDACTED] stated Sandra ran to the front door and was attempting to open it. [REDACTED] said he observed Dan Chapman take about two steps and then raise his hand and was holding a small black semi-auto pistol. [REDACTED] said Dan Chapman then fired one shot at Sandra. Darren stated at that point he began running east toward the car wash. While running [REDACTED] stated he heard more gunfire, at least four shots.

[REDACTED] stated he ran to the car wash and hid inside the auto car wash bay for approximately four to five minutes. At that point [REDACTED] stated he observed Dan Chapman driving out of Sinclair parking lot in his white Ford F-150 truck turning right onto Bus. 60. [REDACTED] said he ran back to his pick up and drove to Cabool PD to report the incident.

At 2107 Texas County Coroner pronounced Sandra Chapman deceased from multiple gun shot wounds.

Based on the information available and the statements of the eye witness to the shooting of Sandra Chapman, I have reason to believe that Dan Chapman caused the death of Sandra Chapman by shooting her, and that Dan Chapman has committed the offense of Murder .
